



# Policy for Campership Applications

1. It is the express desire of Camp Squeah that no child be denied the opportunity to attend summer camp due to financial circumstances.
2. Camp Squeah will endeavour to maintain a Campership Fund that provides adequate funding for what is estimated to be the anticipated need. Campership funds will only be awarded while the fund maintains a balance sufficient to support the requests.
3. Application for this assistance may be made using the Campership Application Form on the reverse side of this form. A separate Campership request must be submitted for each individual camper. Incomplete forms will not be processed.
4. Campership application information remains confidential. Criteria for acceptance and participation in the program are the same for everyone without regard to race, colour, national origin, religion, age, gender or ability.
5. The Camp Squeah Campership Fund will fund to a maximum of ½ the registration costs. Each child's need and the availability of funds will determine the amount of assistance granted. In situations where hardship is demonstrated, full camperships may be considered. This determination will remain at the discretion of the registration staff.
6. The Campership Fund will only apply to one camp session per child.
7. In addition to Campership support Camp Squeah offers interest-free payment plans that should be arranged at the time of registration. Please plan early as all outstanding balances are due before the camp session starts.
8. Prior to applying for Campership support we encourage applicants to pursue other funding sources including the local church, local social service agencies (Rotary, UGM, YMCA, Community Service organizations...) or the Provincial Ministry of Children and Family Development.
9. If your family is receiving Income Assistance, please contact the Ministry of Social Development and Innovation (1-866-866-0800) and apply for support before you sign up for camp. This could help our Campership Fund go farther.
10. Awarding of the Campership Funds continues to be the discretionary, charitable activity of Mennonite Church British Columbia.
11. Camperships are non-refundable.
